Community Pathways Appendix K	This Appendix K is additive to the approved Appendix K and updates temporary authorities related to residential retainer payments. Effective January 1, 2022, providers who have not accessed Appendix K retainer payments or have exhausted Appendix K retainer payments may access retainer payments as stipulated in the base waiver.	3/28/23 - The Appendix K was approved.
Autism Waiver Amendment	<p>This waiver amendment includes:</p> <ol style="list-style-type: none"> <li>1. An increase to the approved total unduplicated number of participant slots for FY22 - FY24.</li> <li>2. A change of service unit increments for respite care, adult life planning, family consultation, intensive individual support services, therapeutic integration, and intensive therapeutic integration to reflect a 15-minute unit increment.</li> <li>3. A change to the daily minimum for therapeutic integration (regular and intensive) to a half hour unit instead of an hour.</li> <li>4. A change to the educational requirement for Service Coordinators.</li> <li>5. The addition of virtual supports as a service delivery option for individual intensive support services, therapeutic integration (regular and intensive), family consultation and adult life planning.</li> <li>6. The lowering of the age requirement and removal of the lifetime limitation for adult life planning.</li> <li>7. A change to allow adult life planning services while receiving residential habilitation.</li> <li>8. A change to qualified assessor for level of care to include licensed psychologist, licensed clinical social worker, licensed clinical professional counselor, certified school psychologist, or an approved service coordinator employed or contracted by the local lead agency, the local education agency, the State, or the State's designee.</li> <li>9. The qualified assessor will also make determinations for Environmental Accessibility Adaptations.</li> <li>10. A modification to the degree requirement for Adult Life Planners and Supervisors from a master's degree to a bachelor's degree.</li> <li>11. A removal of the high school diploma requirement and the addition of a minimum age requirement of 16 for direct care workers for residential habilitation (regular and intensive), intensive individual support services, respite care and therapeutic integration (regular and intensive)</li> <li>12. An update to the provider enrollment process due to the implementation of the electronic provider revalidation and enrollment portal(ePREP)</li> <li>13. A change to the participants' multidisciplinary team.</li> </ol>	5/9/23 - The amendment was approved by CMS.
