# What is PVS?

---

- The Provider Verification System (PVS) is a public-facing search engine for Maryland Medicaid fee-for-service (FFS) provider enrollment.
- A PVS user can search for a provider to see if the provider was active or inactive on specified date.

# Background – Federal Rules

---

PVS functionality helps the Department, and providers, comply with federal Medicaid enrollment regulations.

Providers must enroll with Maryland Medicaid in order to:

- Bill for services (appear as a billing provider on a Medicaid claim)
- Render services (appear as a rendering provider on a Medicaid claim)
- Order, refer, or prescribe billable services
- Provide services billed to a HealthChoice Managed Care Organization (MCO)

# ORP Providers

---

Medicaid is federally required to enroll Ordering, Referring, and Prescribing (ORP) providers for services billable to the Medicaid program.

- If a claim includes an ORP provider, that provider must be an individual practitioner who is actively enrolled in the Medicaid program. (42 CFR § 455.410)
- The ORP requirement enrollment requirement includes attending providers on institutional claims.

# ORP Providers

---

- PVS gives providers who bill services that have been ordered or referred (e.g. labs, diagnostic, DME/DMS providers) a means to determine whether the ORP provider is an actively enrolled individual on the date of service prior to providing the service to a Medicaid recipient.

# **PVS for Provider Users**

---

- PVS offers providers a tool to verify their own Medicaid enrollment status on a specific date.
- PVS also enables provider to check the Medicaid enrollment status of another provider, including an ORP provider.

# Common Ways to Use PVS

---

- **Quick Provider Check.** Verify a provider is actively enrolled, and see basic enrollment information, including provider type, specialties, provider number, revalidation date, and whether they are enrolled as an individual, group, or other (facility) provider.
- **Facility or group status.** Facility or group administrators can see if their service locations are active.

# Common Ways to Use PVS

---

- **Reval Date Check.** Shows the provider's last revalidation date. (Providers must revalidate enrollment every five years. All providers will receive a reval notice in ePREP when MDH schedules their revalidation).
- **Past Enrollment Verification.** Verify if a provider was actively enrolled on a date in the past.



# User Interface

---

- PVS uses the eMedicaid platform. PVS is publicly accessible - No login is required.

- PVS does not show MCO participation status. Please visit the [HealthChoice Provider Directory](#) to find a provider's MCO network information.
- Not all actively enrolled providers accept Medicaid patients. Please do not offer PVS to Medicaid-eligible participants as a provider directory.
