# **National PACE Statistics**

- As of March 2021, 30 states operate 138 PACE programs
- Net enrollment increased 55% in 2019
  - 89% of new enrollments were at PACE organizations operating during the previous year
  - The National PACE Association is sponsoring the PACE 2.0 project to help organizations grow and reach broader communities
- Programs serve an estimated 55,000 participants
- The average participant is 77 years old
- Approximately 90% of participants are dually eligible for Medicare and Medicaid
- 95% of participants live at home
- 98% of family caregivers would recommend PACE

# PACE in Maryland

- Individuals must meet the following criteria:
  - Be at least 55 years old
  - Be certified to need a nursing facility level of care (NFLOC)
  - Agree to receive all health and long-term care services from the PACE provider
  - Have income of no more than 300% of the Supplemental Security Income (SSI) benefit level for Medicaid eligible individuals
  - Live in the PACE service area
  - Be able to live in a community setting with PACE services without jeopardizing their health and safety




# **PACE in MD: Hopkins ElderPlus**

- Located on the campus of Johns Hopkins Bayview Medical Center
- Participants must live within the following ZIP codes:
  - 21202, 21214, 21220, 21227, 21205, 21217, 21221, 21231, 21206, 21218, 21222, 21237, 21213, 21219, 21224, 21052
- Currently serves approximately 150 participants
- Can serve up to 200 participants

### Identifying the Potentially Eligible Population in MD

- The potentially eligible population includes individuals aged 55 years and older in the following populations during fiscal year (FY) 2020:
  - 1915(c) waiver participants who currently receive services in the Home and Community-Based Options (CO) Waiver and the Medical Day Care (MDC) Waiver
  - Participants in the Community First Choice (CFC) state plan program
  - Nursing Facility residents (with fewer than 120 days in the nursing facility and at least one Medicaid long-term care paid day of service )
  - Individuals on the CO Waiver registry (with a Level 1 screen that met the NFLOC proxy generated from questions on activities of daily living, instrumental activities of daily living, cognition, and behaviors)



# **Current Rate Setting Methodology**

- Based on Medicaid fee-for-service (FFS) equivalent experience:
  - Medicaid participants in Baltimore City
  - Aged 55 or older
  - Certified for NFLOC
- Uses a PACE institutionalized case mix experience



# **Expansion Rate Setting Methodology**

- Three proposed payment regions:
  - Baltimore Metro, Washington Metro, and Rural Regions
- Rates are based on FFS equivalent experience of:
  - Medicaid participants in each region
  - Aged 55 or older
  - Certified for NFLOC
- For the rural regions, a statewide experience is used due to the small cohort sizes
- Statewide rates were used for the Medicaid Only and Qualified Medicare Beneficiaries in the Washington Region due to small cohort sizes
- Expansion rates will vary based on institutional case mix experience
