In an effort to give timely notice to the pharmacy community concerning important pharmacy topics, the Department of Health and Mental Hygiene's (DHMH) **Maryland Medicaid Pharmacy Program** (MMPP) has developed the **Maryland Medicaid Pharmacy Program Advisory**. ## Important Changes Related to Prior Authorization Requests for Fee-for-Service Members

**Effective March 1, 2011**, Prior Authorizations (PAs) for Growth Hormones, Nutritional Supplements, and multi-source Brand-Name drugs for Maryland Medicaid fee-for-service (FFS) recipients will be handled by our pharmacy claims processor, (ACS telephone # 1-800-932-3918, fax # 1-866-440-9345).

Requests for PAs for these drugs, as well as requests for PAs for all drugs listed below, must be received in writing using the proper forms. PAs for highlighted categories are reviewed by ACS; non-highlighted categories continue to be reviewed by the pharmacy team at Department of Health and Mental Hygiene.

Providers can download these forms or call 1-800-932-3918 and request that a form be faxed to them. The completed form must be faxed to the number indicated on each form. Each form also gives a telephone number to call with questions or follow-up. It is advisable to dispose of any old Maryland Medicaid FFS PA forms that you may have on hand and download the new forms from the web.
