Change in Online Preferred Drug List/Formulary Vendor

Effective February 1, 2018, Epocrates® will no longer be available as an online formulary resource for Maryland Medicaid's Fee-for-Service (FFS) Preferred Drug List (PDL) and HealthChoice Managed Care Organization (MCO) formulary information. The Department is transitioning to a new online formulary management resource, Formulary Navigator™, provided through Managed Markets Insights & Technology (MMIT). This application provides a most up-to-date list of medications covered under the FFS PDL program and formulary information for all of the MCOs, including coverage details, prior authorization/restrictions, (e.g. quantity, age) and links to additional information. This easy-to-access resource for clinicians, administrators, providers and participants is available at no cost.

 - ⇒ Brand and generic search: type in the entire product name for results (e.g. for amoxicillin you must type "amoxicillin" for results to populate)
 - → Therapeutic class: full list of products and coverage information (note: some medications are listed in more than one therapeutic class, depending on indication)
