**ORDER OF MODIFICATION**

The Maryland Board of Pharmacy (the "Board") is in receipt of a petition from Thomas G. Bolt, License No. 08155, requesting modification of the terms of probation as set forth in a Consent Order, dated March 6, 2008. The Consent Order provides that Mr. Bolt may petition for modification of the probationary terms after one (1) year of probation. Specifically, Mr. Bolt requests that he be permitted to practice in a dispensing role, and that the required frequency of his urine screenings, therapy sessions and AA/NA meetings be decreased. Upon consideration of Mr. Bolt's request, the Board ordered that Mr. Bolt undergo a substance abuse evaluation regarding his fitness to resume dispensing activities. Upon receipt of the evaluation, the Board voted to modify the terms of probation as ordered below.

**ORDER**

It is this 29<sup>th</sup> day of March, 2010, by an affirmative vote of the Maryland Board of Pharmacy, hereby,

**ORDERED** that Mr. Bolt may practice pharmacy as a dispensing pharmacist with access to prescription drugs under the following conditions:

1. Mr. Bolt may not practice during night shifts;
2. Mr. Bolt shall only dispense in a pharmacy setting in which another pharmacist is present;
3. Mr. Bolt may not serve as a pharmacy manager;
4. Mr. Bolt shall insure that the pharmacy permit holder maintain a perpetual CDS

inventory, which is not balanced by Mr. Bolt;

5. Due to renewed access to controlled dangerous substances, Mr. Bolt shall submit to random, weekly urine screenings; and be it further,

**ORDERED** that Mr. Bolt may decrease his frequency of psychotherapy sessions from bi-weekly to monthly; and be it further,

**ORDERED** that Mr. Bolt may decrease his frequency of attendance to NA/AA meetings from twice weekly to once weekly; and be it further,

**ORDERED** that the remaining probationary terms of the March 6, 2008, Consent Order are continued in this Order, *to wit*:

1. Mr. Bolt shall provide the Board with documentation of his attendance at NA/AA meetings.

2. Mr. Bolt shall be responsible for insuring that his therapist submits quarterly progress reports to the Board.

3. Mr. Bolt shall not practice in excess of forty (40) hours per week;

4. Mr. Bolt is responsible for insuring that his pharmacy employer(s) submit quarterly performance reports to the Board; and be it further,

**ORDERED** that all other terms of the Consent Order dated March 6, 2008, remain in full force and effect

**ORDERED** that this is a formal order of the Maryland Board of Pharmacy and as such is a public document pursuant to the Maryland Annotated Code, State Government Article, Section 10-617(h).
