**PRE-CHARGE CONSENT ORDER**

**Background**

The Maryland Board of Pharmacy (the "Board") received notification from the National Association of Boards of Pharmacy ("NABP") of disciplinary action taken against Jasper Ileka (the "Respondent") by the Texas Board of Pharmacy on November 9, 2010. The Texas Board of Pharmacy disciplined the Respondent for submitting a fraudulent application by reciprocity in failing to disclose a prior criminal conviction and disciplinary actions.

In lieu of instituting formal proceedings against the Respondent, in accordance with the Maryland Pharmacy Act, Md. Code Ann., Health Occ. § 12-101 *et seq.*, the Board and the Respondent have agreed to resolve this matter as set forth in this Consent Order.

**FINDINGS OF FACT**

1. The Respondent is a licensed pharmacist in Maryland, under License Number 08695, which expires in February 2012.
2. The Respondent is also licensed and currently resides in Rhode Island.
3. On August 6, 2009, the Respondent submitted an application for licensure to the Texas Board of Pharmacy.

4. On June 11, 2010, the Texas Board of Pharmacy issued a preliminary notice to the Respondent of its intent to consider denial of his application based on the Respondent's alleged failure to disclose his prior criminal conviction and disciplinary actions issued by the Illinois Board of Pharmacy.
5. On November 9, 2010, the Texas Board of Pharmacy issued a public order against the Respondent granting him a license and disciplining him for submitting a fraudulent application for licensure by reciprocity. The Respondent neither admitted nor denied the allegations.
6. The Texas Order sanctioned the Respondent's Texas license by issuing a suspension of one (1) year, which suspension was probated, and assessing a probation fee of \$1,200 and an administrative penalty of \$1,000.

#### CONCLUSION OF LAW

Based on the foregoing Findings of Fact, the Board concludes that the Respondent is subject to disciplinary action in accordance with Md. Code Ann., Health Occ. §§12-313(b) (24).

#### ORDER

Based on an affirmative vote of a majority of the Board, it is this 22<sup>nd</sup> day of February, 2012, hereby:

**ORDERED** that the Maryland license to practice pharmacy held by JASPER ILEKA shall be REPRIMANDED; and be it further,


**ORDERED** that the Respondent shall pay a FINE of \$1,000, payable to the Maryland Board of Pharmacy within ninety (90) days of the date of this Order; and be it further,

**ORDERED** that in the event the Respondent violates any condition of this Consent Order, the Respondent shall be subject to further disciplinary action after notice and an opportunity for a hearing; and be it further,

**ORDERED** that the Respondent shall be responsible for all costs associated with this Consent Order; and be it further,

**ORDERED** that this is a formal order of the Maryland Board of Pharmacy and as such is a public document pursuant to the Maryland Annotated Code, State Government Article, Section 10-617 (h).

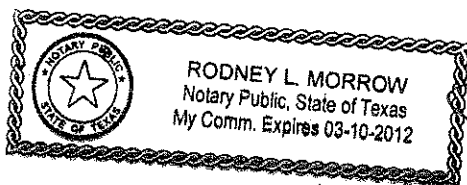
2. By signing this Consent, I waive any rights I may have had to contest the findings and determinations contained in this Consent Order.
