PRE-CHARGE CONSENT ORDER

Background

The Maryland Board of Pharmacy (the “Board”) conducted an annual inspection of Union Hospital of Cecil County Pharmacy (the “Pharmacy”) on August 3, 2022. During the inspection, it was determined that the Pharmacy had been acquired by another entity, ChristianaCare, on January 1, 2020. The Pharmacy did not submit to the Board a Change of Ownership application and was continuing to operate under the permit of the prior owner of the Pharmacy in violation of the Maryland Pharmacy Act.

In lieu of instituting formal proceedings against the Pharmacy in accordance with the Maryland Pharmacy Act, Md. Code Ann., Health Occ. § 12-101 *et seq.*, the Board and the Pharmacy have agreed to resolve this matter as set forth in this Pre-Charge Consent Order.

FINDINGS OF FACT

1. Union Hospital of Cecil County Pharmacy was issued a Maryland Pharmacy Permit, Permit Number P00796, on January 1, 1908. The Pharmacy renewed its permit with the Board on May 17, 2022.
2. On or about August 3, 2022, the Board conducted an annual inspection of the

Pharmacy. During that inspection, the inspector observed prescription drug labels indicating the Pharmacy's name as "ChristianaCare – Union Hospital."

3. The Pharmacy informed the inspector that it was acquired by ChristianaCare, effective January 1, 2020.
4. ChristianaCare – Union Hospital' is a d/b/a name for Union Hospital of Cecil County, Inc. Christiana Care Health Services, Inc. (ChristianaCare) acquired Affinity Health Alliance, Inc. on January 1, 2020 through a membership substitution. Affinity Health Alliance was, and continues to be, the sole member of Union Hospital of Cecil County, Inc.
5. The Pharmacy failed to notify the Board of its closing of the permit and submit to a closing inspection.
6. The Pharmacy did not submit to the Board a Change of Ownership application, and the new owner, ChristianaCare, was not issued a pharmacy permit authorizing it to engage in pharmacy operations.¹
7. Pharmacy permits are not transferrable.

CONCLUSIONS OF LAW

Based on the foregoing Findings of Fact, the Board concludes that Union Hospital of Cecil County Pharmacy is subject to discipline in accordance with Md. Code Ann., Health Occ. §§ 12-401 and 12-408 and COMAR 10.34.14.

¹ On April 6, 2022, the new pharmacy submitted written notice of the change in ownership to the Office of Controlled Substances Administration, a unit of the Department of Health which issues CDS registrations to pharmacies.

ORDER

Based upon an affirmative vote of the Maryland Board of Pharmacy under the authority of Md. Code Ann., Health Occ. § 12-410, it is this ^{29th} January day of 2023, hereby,

ORDERED that Union Hospital of Cecil County, Permit No. P00796, shall pay a FINE in the amount of THREE THOUSAND DOLLARS (\$3,000.00), payable to the Maryland Board of Pharmacy within thirty (30) days of the date of this Order, and mailed to:

NOTE: Please include the case number, 23-098, on your check or money order to ensure proper assignment to this case; and be it further,

ORDERED that Union Hospital of Cecil County shall comply with all laws and regulations governing the operation of a pharmacy, including laws governing change of ownership; and be it further,

ORDERED that in the event that Union Hospital of Cecil County violates any of the terms above, the Board, after notice and an opportunity for a hearing, and a determination of a violation, may impose any disciplinary sanction it deems appropriate, including suspension, revocation, and fines, said violation being proven by a preponderance of the evidence; and be it further,

ORDERED this order resolves all causes of action related to issuance, use, notification, change of ownership, or any other action whatsoever relating in any way to

pharmacy permit(s) that the Board has against Union Hospital of Cecil County, and its parent, subsidiaries and affiliates, and its and their officers, directors, employees and agents, its predecessors, successors and assigns, heirs, executors and administrators of and from all manner of actions and causes if actions and demands whatsoever in law or in equity, arising on or before the date of the order.

ORDERED that this is a formal order and as such is a public document pursuant to the Maryland Public Information Act, Md. Code Ann., General Provisions Article § 4-101 *et seq.*
