ORDER TERMINATING PROBATION AND
REINSTATING PHARMACY LICENSE

By Order dated October 10, 1984 ("the 1984 Order"), the Maryland Board of Pharmacy (the "Board") found Vicki Weiss, P.D. (the "Respondent") guilty of violating Section 12-311 (b) (1) and (23) of the Health Occupations Article. The Board revoked the Respondent's license; the revocation was immediately stated and Respondent was placed on probation subject to certain conditions (the "Conditions of Probation").

By letter dated May 20, 1986, Respondent petitioned the Board for reinstatement of her license to practice pharmacy in Maryland without any condition or restriction. At its meeting on June 4, 1986, the Board reviewed Respondent's petition for reinstatement. Based on its review of that petition and the reports submitted to the Board by the persons monitoring Respondent's progress pursuant to the Conditions of Probation, the Board determined that respondent had satisfactorily fulfilled all of the Conditions of Probation contained in the 1984 Order.

FINDINGS OF FACT

The Board finds that Respondent has satisfactorily complied with all the Conditions of Probation imposed by its 1984 Order.

CONCLUSION OF LAW

The Board concludes as a matter of law that it is appropriate to terminate Respondent's Conditions of Probation and to reinstate her pharmacy license without any condition or restriction.

ORDER

UPON THE FOREGOING Finding of Fact and Conclusion of Law, it is this 16 day of July, 1986 by a unanimous vote of a quorum of the Board ORDERED that effective as of the date of this Order, the Conditions of Probation imposed on Respondent's practice of pharmacy by the Board's 1984 Order are hereby **TERMINATED** and of no force and effect; and be it further


ORDERED that Respondent's license to practice pharmacy in the State be **REINSTATED** without any condition or restriction whatsoever.

CONSENT ORDER

The Virginia State Board of Pharmacy, by counsel, and Vickie Weiss freely and voluntarily enter into the following Consent Order.

FINDINGS OF FACT

1. Vickie Weiss holds License No. 5828, issued by the Virginia State Board of Pharmacy;
2. Vickie Weiss, while employed in her professional capacity as a registered pharmacist at Drug Fair, Inc., Reston, Virginia, diverted certain controlled substances during the period from March 1980, through June 1980, for her personal use and without a prescription from a licensed physician;
3. In a signed statement before W. Addison Hurst, Investigator for the Department of Health Regulatory Boards, on June 30, 1980, Vickie Weiss admitted to the truth of the facts as stated in paragraph 2 above.

CONCLUSION OF LAW

The Board concludes that the Findings of Fact constitute violations of the law as follows:

1. Findings of Fact Nos. 2 and 3 constitute a violation of §§ 54-524.67(a) and 54-524.22:1(i) of the Code of Virginia (1950), as amended.

CONSENT

Vickie Weiss, by affixing her signature hereon, agrees to the following:

1. She acknowledges that she has been specifically

advised to seek advice of counsel prior to signing this document;

2. She acknowledges that she is fully aware that without her consent, no legal action can be taken against her except after a hearing held in accordance with the Virginia Administrative Process Act, § 9-6.14 et seq. of the Code of Virginia (1950), as amended;

3. She acknowledges that she has the following rights among others: the right to a formal fact finding hearing before the Board, to reasonable notice of said hearing, to representation by counsel, and the right to cross-examine witnesses against her;

4. She waives all such rights to a hearing;

5. She admits the truth of the above Findings of Fact;

6. She acknowledges authority granted to the State Board of Pharmacy to impose a monetary penalty pursuant to §§ 54-961 and 18.2-261 of the Code of Virginia (1950), as amended;

7. She consents to the entry of the following Order affecting her license to practice pharmacy in the Commonwealth of Virginia.

ORDER

On the basis of the foregoing Findings of Fact, Conclusions of Law, and Consent of the licensee, the Virginia State Board of Pharmacy, effective upon entry of this Order, hereby ORDERS that License No. 5828, issued to Vickie Weiss to practice pharmacy in the Commonwealth of Virginia, is hereby SUSPENDED for a period of thirty days. It is further hereby ORDERED that said SUSPENSION BE STAYED and the license of Vickie Weiss be placed on probation for a period of two years with the following terms and conditions:

1. Vickie Weiss agrees to inform the Board of any

change of address during the period of probation;

2. Vickie Weiss agrees to inform the Board of the date she resumes the practice of pharmacy and the name and address of her employer as well as any subsequent change of employment during the probationary period;

3. Vickie Weiss agrees, upon the resumption of employment as a registered pharmacist, to inform her employer that the Board has placed her license on probation and further consents to the release of information in the Board's Bulletin that said probation is due to diversion of controlled substances, for her personal use and without a prescription from a licensed physician;

4. Vickie Weiss agrees to enroll in a drug therapy program acceptable to the Board and agrees to have her therapist supply the Board every six months with reports as to her progress including a discharge summary at the time her therapy is terminated; or she agrees to supply the Board with a letter from a licensed therapist or physician which states that Vickie Weiss is not now drug dependent and is therefore, not in need of therapy for such dependency;

5. Vickie Weiss agrees to maintain a course of conduct in her professional capacity commensurate with the requirements of Title 54, Chapter 15.1 of the Code of Virginia (1950), as amended, and the Regulations of the State Board of Pharmacy;

Further, the Board hereby imposes a monetary penalty of FIVE HUNDRED DOLLARS (\$500.00) pursuant to §§ 54-951 and 18.2-261 of the Code of Virginia (1950), as amended, to be remitted to the Board within sixty days from date of entry of this Order.

Violations of the terms and conditions hereof shall constitute grounds for revocation of the license of Vickie Weiss.

In the event that she violates any of the terms and conditions thereof or any other provision of law, a formal hearing shall be convened to determine whether the license of Vickie Weiss shall be revoked.
