2                   **Subtitle 17 [SWIMMING POOLS AND SPAS] *AQUATIC FACILITIES AND VENUES***

3                   **Chapter 01 [Public Swimming Pools and Spas] *Aquatic Facilities and Venues***

4                   **Authority: Health-General Article, §§2-102, 2-104, 18-102, and 20-303, Annotated Code of**  
5                   **Maryland, and U.S.C. §8003**

6                   **.01 Purpose and Scope.**

7                   A. The purpose of this chapter is to enact regulations that protect and promote the public health  
8                   and safety of individuals at [public spas and pools] *aquatic facilities and venues* in Maryland.  
9                   [Public pools] *Aquatic facilities and venues* include limited public-use pools, recreational pools,  
10                  [and semipublic pools. Public spas include semipublic spas] *semipublic pools, public spas,*  
11                  *semipublic spas, and public spray grounds.*

12                  B. This chapter adopts construction standards, updates disinfection standards, recognizes certain  
13                  new technologies and design concepts, and establishes minimum [criteria for public pools and  
14                  spas] *standards for aquatic facilities and venues.*

15                  **.02 Exclusions.**

16                  This chapter does not apply to a:

17                  A. Private pool, except for a private pool defined as a limited public-use pool in Regulation .04B  
18                  of this chapter;

19                  B. Private spa;

20                  C. Pool or spa that is completely emptied of water, disinfected, and refilled with water between  
21                  each use and that is intended for use or used by a single individual during each use; [or]

22                  D. Pool [or a], spa, *or spray ground* at a bed and breakfast, if the bed and breakfast facility has  
23                  eight or fewer guest rooms[.]; *or*

24                  E. *Private spray ground.*

25                  **.03 [Previously Constructed Pools and Spas.]**

26                  A. Except as provided in §C of this regulation, the owner of a pool or spa that was constructed  
27                  before February 10, 1997 is exempt from bringing the pool or spa into compliance with:

28                  (1) Regulations .13C, .14A(3), .17C, .18A(3), .22, .24, and .35 of this chapter; and

1 (2) Notwithstanding any exemption set forth at §A(1) of this regulation, the diving area  
2 dimensions of Regulation .27B of this chapter if the diving area is in compliance with American  
3 National Standard for Public Swimming Pools.

4 B. Except for Regulation .28 of this chapter, the owner of a pool or spa that was constructed  
5 before February 10, 1997:

6 (1) Shall maintain the pool or spa, including appurtenant structures and equipment as originally  
7 constructed; and

8 (2) May complete a repair according to Regulation .06P that restores the pool or spa to its  
9 original condition before damage or deterioration without the component complying with the  
10 requirements of this chapter.

11 C. For a pool or spa that was constructed before February 10, 1997, the exemptions in §A of this  
12 regulation do not apply if:

13 (1) The pool or spa has a condition that jeopardizes the health or safety of the public, in which  
14 case the owner shall ensure that the condition is corrected to meet the requirements of this  
15 chapter;

16 (2) An owner intends to alter the pool or spa, including appurtenant structures and equipment in  
17 which case the owner shall ensure that the alteration complies with the requirements of this  
18 chapter; or

19 (3) A suction outlet is not in compliance with Regulation .28 of this chapter, in which case the  
20 owner shall ensure that the suction outlet is altered to meet the requirements of Regulation .28 of  
21 this chapter for suction entrapment prevention.]

### 1 **Definitions.**

2 *A. In this chapter, the following terms have the meanings indicated.*

3 *B. Terms Defined.*

4 *(1) “Agitated water” means an aquatic venue with mechanical means to discharge, spray, or*  
5 *move the water's surface above and/or below the static water line of the aquatic venue so people*  
6 *are standing or playing vertically.*

7 *(1-1) “AF” means alkalinity factor.*

8 *(2) Alteration.*

9 *(a) “Alteration” means to:*

10 *(i) Change or modify an equipment room, a bathhouse, a component, or the configuration of an*  
11 *aquatic venue;*

12 *(ii) Move a component from one location or position to another; or*

13 *(iii) Install a new component.*

14 *(b) “Alteration” does not include a repair or replacement.*

15 *(3) “Approved” means found by the Secretary to be in satisfactory compliance with applicable*  
16 *statutes and regulations promulgated or enforced by the Secretary.*

17 *(4) “APSP” means the Association of Pool and Spa Professionals.*

18 *(5) “Aquatic facility” means a physical place that contains one or more aquatic venues and*  
19 *support infrastructure.*

20 *(6) Aquatic venue.*

21 *(a) “Aquatic venue” means an artificially constructed structure or modified natural structure*  
22 *where the general public is exposed to water intended for recreational or therapeutic purpose.*

23 *(b) “Aquatic venue” includes a public pool, spa, and spray ground.*

24 *(c) “Aquatic venue” does not include a private pool, spa, or spray ground.*

25 *(7) “Barrier” means a fence, wall, or a combination of a fence and wall that completely*  
26 *surrounds and obstructs access to the aquatic venue.*

27 *(7-1) “CF” means calcium hardness factor.*

- 1 (8) “Cfm” means cubic feet per minute.
- 2 (9) “Component” means:
- 3 (a) A piece of aquatic venue equipment;
- 4 (b) A deck;
- 5 (c) A barrier;
- 6 (d) One or more skimmers;
- 7 (e) One or more filters, including piping and valves;
- 8 (f) A ventilation system;
- 9 (g) Lighting provided for water, deck, and walkways; or
- 10 (h) Pipe material for aquatic venue water.
- 11 (9-1) “CPR” means cardiopulmonary resuscitation.
- 12 (10) “Critical violation” means failure to comply with:
- 13 (a) Regulation .06;
- 14 (b) Regulation .06-1;
- 15 (c) Regulation .08;
- 16 (d) Regulation .21;
- 17 (e) Regulation .25;
- 18 (f) Regulation .28;
- 19 (g) Regulation .29;
- 20 (h) Regulation .40;
- 21 (i) Regulation .43;
- 22 (j) Regulation .44;
- 23 (k) Regulation .45;

- 1 (l) Regulation .46; and

- 3 (11) “Deck” means surface areas serving the aquatic venue, including the dry deck, perimeter  
4 deck, and pool deck.
- 5 (12) “Department” means the Department of Health and Mental Hygiene.
- 6 (12-1) “DPD” means diethyl-p-phenylene diamine.
- 7 (13) Dry deck.
- 8 (a) “Dry deck” means all pedestrian surface areas within the aquatic venue barrier not subject  
9 to frequent splashing or constant wet foot traffic.
- 10 (b) “Dry deck” does not include perimeter deck, pool deck or landscape areas.
- 11 (13-1) “EDTA” means ethylenediamine-tetraacetate.
- 12 (14) “Flat water” means an aquatic venue in which the water line is static except for movement  
13 made by users usually as a horizontal use as in swimming or from diving spargers.
- 14 (15) “Full compliance inspection” means an inspection that verifies compliance with this  
15 chapter.
- 16 (16) “Gpm” means gallons per minute.
- 17 (17) “Handhold” means a coping, horizontal bar, or cantilevered decking.
- 18 (18) “Latch” means a device attached to a gate for the purpose of securing the gate closed.
- 19 (19) Latch release.
- 20 (a) “Latch release” means a mechanism to disengage the latch to allow the gate to open.
- 21 (b) “Latch release” includes but is not limited to an electronic lock, a key fob system, or a swipe  
22 card entry system.
- 23 (20) “Lazy river” means an aquatic venue where water is moved by pumps or other means of  
24 propulsion that transports bathers over a defined path.
- 25 (21) “Lifeguard” means an individual who is 15 years old or older and who has a valid lifeguard  
26 certificate from:
- 27 (a) The American Red Cross;

- 1 (b) *The Boy Scouts of America, not including a lifeguard merit badge;*  
2 (c) *The Young Men's Christian Association;*  
3 (d) *Ellis and Associates' National Pool and Waterpark Lifeguard Training;*  
4 (e) *Starfish Aquatics Institute; or*  
5 (f) *An organization with a lifesaving training program equivalent to that of the American Red*  
6 *Cross as determined by the Department.*
- 7 (22) *Limited public-use pool.*
- 8 (a) *"Limited public-use pool" means a private pool which is made available for use by:*
- 9 (i) *Children in family day care under the care of a family day care provider at a family day care*  
10 *home as defined in COMAR 13A.15.01; or*
- 11 (ii) *An organized group, agency, or other person for swimming lessons or water safety training.*
- 12 (b) *"Limited public-use pool" does not include a pool that is emptied of water, disinfected, and*  
13 *refilled with water between each use.*
- 14 (23) *"Make-up water" means the potable water used to maintain the water level in a pool, spa,*  
15 *or within the surge tank of a spray ground.*
- 16 (24) *"NSF" means the National Sanitation Foundation International.*
- 17 (25) *"Operator" means a person who supervises, controls, conducts, or manages the operation*  
18 *of an aquatic facility or venue.*
- 19 (26) *"Owner" means a person who has a legal interest in an aquatic facility or venue or in the*  
20 *property on which an aquatic facility or venue is or is to be constructed or altered.*
- 21 (27) *"Oxidation reduction potential (ORP)" means a measure of the tendency for a solution to*  
22 *either gain or lose electrons.*
- 23 (28) *"Perimeter deck" means the hardscape surface area immediately adjacent to and within*  
24 *four feet of the edge of the public pool, spa or spray ground.*
- 25 (29) *"Person" means an individual, receiver, trustee, guardian, personal representative,*  
26 *fiduciary, or representative of any kind and any partnership, firm, association, corporation, or*  
27 *other entity.*
- 28 (30) *"PHMB" means poly (iminoimidocarbonyliminoimidocarbonyliminohexamethylene*  
29 *hydrochloride) or polyhexamethylene biguanidine hydrochloride.*

1 (31) *“Plummet” means the center of the end of the diving board over the water, in the position*  
2 *where it will be installed.*

3 (32) *“Pool” means an artificial enclosure of water that is used for the immersion of the human*  
4 *body for recreation, therapy, or exercise, including a structure that is installed in the ground,*  
5 *above ground, outside, or in a building or portable structure.*

6 (33) *“Pool deck” means the surface areas serving the aquatic venue, beyond perimeter deck,*  
7 *which is expected to be regularly trafficked and made wet by bathers.*

8 (34) *“Ppm” means parts per million.*

9 (35) *“Primary disinfectant” means chlorine or bromine.*

10 (36) *Private pool, private spa, and private spray ground.*

11 (a) *“Private pool,” “private spa,” and “private spray ground” mean a pool, spa, or spray ground*  
12 *that is:*

13 (i) *Not open to the public;*

14 (ii) *On a property on which not more than eight private residences are located; and*

15 (iii) *Used exclusively by the residents of the property and nonpaying individuals invited to use*  
16 *the pool, spa, or spray ground by a resident.*

17 (b) *“Private pool,” “private spa,” or “private spray ground” include a pool, spa, or spray*  
18 *ground at a private residence used for short-term rentals including weekly, monthly, or seasonal*  
19 *rentals.*

20 (37) *“PSI” means pounds per square inch.*

21 (38) *Public pool, public spa, and public spray ground.*

22 (a) *“Public pool,” “public spa,” and “public spray ground” mean a pool, spa, or spray ground*  
23 *that is not a private pool, spa, or spray ground.*

24 (b) *“Public pool” includes a:*

25 (i) *Limited public-use pool;*

26 (ii) *Recreational pool; and*

27 (iii) *Semipublic pool.*

28 (c) *“Public spa” includes a semipublic spa.*

1 (39) “Recreational pool” means a pool that:

2 (a) Is not a limited public-use pool, private pool, semipublic pool, or spray ground;

3 (b) Is provided as the owner's primary business or the facility's primary purpose, for example, a  
4 swim club or similar facility;

5 (c) Is open for general admission to the public;

6 (d) Is available to an individual paying a fee for use of the pool;

7 (e) Is equipped with a sliding board, diving platform, water slide, water flume, or water  
8 recreational play equipment that is built into or attached to the pool structure;

9 (f) Is provided by, or used by a:

10 (i) Youth camp;

11 (ii) College, university, or school;

12 (iii) Municipality;

13 (iv) Water park, amusement park, or water recreational attraction; or

14 (v) An apartment complex, housing subdivision, or mobile home park with more than ten units,  
15 except as provided in §B(45) of this regulation; or

16 (g) Is used more than 4 times a week for swimming lessons, water safety instruction, or  
17 swimming competition.

18 (40) Repair.

19 (a) “Repair” means substituting a component having the same make and model as the previously  
20 approved component for the previously approved component.

21 (b) “Repair” does not include:

22 (i) Replacements;

23 (ii) Alterations;

24 (iii) Installation of additional equipment; or

25 (iv) Substitutions involving a component which does not meet the requirements of this chapter.

26 (41) Replacement.

- 1 (a) “Replacement” means substituting a component, which has a different make or model but  
2 has the same operating characteristics and certifications as the previously approved component,  
3 for the previously approved component.
- 4 (b) “Replacement” does not include:
- 5 (i) Repairs;
- 6 (ii) Alterations;
- 7 (iii) Installation of additional equipment; or
- 8 (iv) Substitutions involving a component which does not meet the requirements of this chapter.
- 9 (c) “Replacement” includes the installation of any component which is being installed at an  
10 aquatic facility that received approval after construction from the Secretary prior to May 30,  
11 2016, to bring an aquatic facility into compliance with new provisions of this chapter.
- 12 (42) “Routine inspection” means an inspection that includes but is not limited to verifying  
13 compliance with:
- 14 (a) Regulation .40;
- 15 (b) Regulation .44;
- 16 (c) Regulation .45;
- 17 (d) Regulation .46;
- 18 (e) Regulation .48; and
- 19 (f) Regulation .48-1.
- 20 (43) “Safety vacuum release system” means a vacuum release system that:
- 21 (a) Is capable of providing vacuum release at a suction outlet caused by a high vacuum  
22 occurrence due to a suction outlet flow blockage; and
- 23 (b) Complies with 15 U.S.C. §8003.
- 24 (44) “Secretary” means the Secretary of Health and Mental Hygiene or the Secretary's designee,  
25 including a local health officer.
- 26 (45) “Semipublic pool” and “semipublic spa” means a pool or spa at a facility that:
- 27 (a) Has pool use or spa use restricted to an individual:

- 1 *(i) Staying at the facility, where the facility is a temporary dwelling, including a hotel, motel,*  
2 *campground, bed and breakfast having nine or more guest rooms, or similar temporary*  
3 *dwelling;*
- 4 *(ii) Holding membership at the facility, where the facility is an adult health club, retirement*  
5 *community, marina, condominium, or similar facility;*
- 6 *(iii) Residing at an apartment complex, housing subdivision, or mobile home park with ten units*  
7 *or less;*
- 8 *(iv) Receiving treatment at a physical therapy center pool or spa, where the pool or spa is used*  
9 *for providing therapy; or*
- 10 *(v) Who is the owner or an owner of the pool or spa; and*
- 11 *(b) Has a pool or spa that is not:*
- 12 *(i) Open for admission to the general public, except as provided in §B(45) of this regulation;*
- 13 *(ii) Available to an individual upon the payment of a fee for the use of the pool and spa;*
- 14 *(iii) A limited public-use pool, a private pool, a private spa, a private spray ground, a*  
15 *recreational pool, or a spray ground;*
- 16 *(iv) Equipped with a swimming pool sliding board, diving platform, water slide, water flume, or*  
17 *water recreational play equipment that is built into or attached to the pool structure; and*
- 18 *(v) At a bed and breakfast that has eight or fewer guest rooms.*
- 19 *(46) "Shallow" means 5 feet or less in depth.*
- 20 *(47) Spa.*
- 21 *(a) "Spa" means a pool, hot tub, or whirlpool that is:*
- 22 *(i) Primarily designed for relaxation or therapeutic use and not for swimming;*
- 23 *(ii) Not more than 4 feet in depth;*
- 24 *(iii) Equipped with built-in seats or benches; and*
- 25 *(iv) Usually equipped with hydrotherapy jets, heated water, an air injection system, or some*  
26 *combination of these features.*
- 27 *(b) "Spa" does not include a pool, hot tub, or whirlpool classified as a swim spa.*

- 1 (48) *“Splash zone” means the maximum distance the water from a spray ground can project*  
2 *horizontally at designed flow rates.*
- 3 (49) *Spray ground.*
- 4 (a) *“Spray ground” means an area for water play into which treated and filtered water is*  
5 *sprayed but not allowed to accumulate on the play surface.*
- 6 (b) *“Spray ground” includes splash pads and interactive fountains.*
- 7 (c) *“Spray ground” does not include decorative fountains where interaction with the water is*  
8 *prohibited.*
- 9 (50) *“Stadium seating” means an area of high-occupancy seating provided above the pool level*  
10 *for observation.*
- 11 (51) *“Supplemental disinfectant” means, other than chlorine or bromine, any disinfectant,*  
12 *sanitizer, or antimicrobial pesticide approved by the Environmental Protection Agency.*
- 13 (52) *“Swimming pool slide” means a water-contact device less than 10 feet in height that an*  
14 *individual may use to enter a pool by sliding down an inclined plane.*
- 15 (53) *“Swim spa” means a spa designed to create a current of water against which an individual*  
16 *may swim for exercise or therapy.*
- 17 (53-1) *“TDSF” means total dissolved solids factor.*
- 18 (53-2) *“TF” means temperature factor.*
- 19 (54) *Theoretical peak occupancy.*
- 20 (a) *“Theoretical peak occupancy” means the anticipated peak number of bathers in an aquatic*  
21 *venue and the anticipated peak number of occupants on the decks of an aquatic facility.*
- 22 (b) *“Theoretical peak occupancy” is calculated by dividing the surface area in square feet of the*  
23 *aquatic venue by the density factor (D) in Regulation .19B of this chapter, that fits the specific*  
24 *aquatic venue being considered.*
- 25 (55) *“Therapy pool” means a pool that is exclusively used in the physical treatment of a disease,*  
26 *injury, or disorder.*
- 27 (56) *“Total dynamic head” means the hydraulic calculation of the resistance to flow in a*  
28 *circulation system based on the Hazen-Williams formula in Regulation .25C of this chapter.*
- 29 (57) *“Tube ride” means a pool designed to move an individual on a tube, raft, or other floating*  
30 *support along a channel filled with water.*

- 1 (58) "Turnover rate" means the time required to circulate a quantity of water equal to the pool  
2 or spa volume or for a spray ground, the surge tank volume.
- 3 (59) "Unblockable drain" means a suction outlet such that:
- 4 (a) Its perforated area cannot be shadowed by the area of the 18 inch by 23 inch body blocking  
5 element of the American National Standard for Suction Fittings for Use in Swimming Pools,  
6 Wading Pools, Spas, and Hot Tubs (ANSI/APSP-16 2011); and
- 7 (b) The rated flow through the remaining open area cannot create a suction force in excess of  
8 the removal force values in Table 1 of American National Standard for Suction Fittings for Use  
9 in Swimming Pools, Wading Pools, Spas, and Hot Tubs (ANSI/APSP-16 2011).
- 10 (60) User load.
- 11 (a) "User load" means the maximum number of individuals, as determined by the Secretary, for  
12 sanitary purposes, allowed:
- 13 (i) In a pool or spa based on the water surface area and water depths; or
- 14 (ii) To use a spray ground based on the splash zone area.
- 15 (61) "Wading pool" means a pool with a water depth of 24 inches or less that is intended for use  
16 by children.
- 17 (62) "Warm water" means an aquatic venue with a water temperature over 90°F (32°C).
- 18 (63) Water recreational attraction.
- 19 (a) "Water recreational attraction" means special water circulation and operational features or  
20 unconventional design and operational features which provide patrons recreational activity  
21 different from that associated with a conventional swimming pool.
- 22 (b) "Water recreational attraction" includes but is not limited to a:
- 23 (i) Piece of water play equipment;
- 24 (ii) Lazy river;
- 25 (iii) Tube ride;
- 26 (iv) Water slide; and
- 27 (v) Wave pool.

1 (c) "Water recreational attraction" does not include a spray ground, a floating or temporarily  
2 attached volleyball net, or a floating or temporarily attached basketball hoop.

3 (64) "Water slide" means a water-contact amusement ride when the height of the slide is 10 feet  
4 or more.

5 (65) "Wave pool" means a pool designed with mechanical or hydraulic apparatus to generate  
6 waves in the pool.

- 17 (2) Establish breakpoint when the combined chlorine level is *at or over* [0.2] *0.4* ppm.
- 18 D. Chlorine Gas Feeders. An owner of [a recreational pool, semipublic pool, or public spa] *an*

- 20 (1) Equipment installation, and operation of a chlorine gas feeder are in compliance with the  
21 American National Standard for Public Swimming Pools, with the exception that the word  
22 "shall" is substituted for the word "should", and the owner is required to comply with the  
23 specifications of Appendix E; and
- 24 (2) Recirculated water is treated downstream of the chlorine gas injection point to maintain the  
25 water's pH between 7.2 and 7.8. ] *not allow the use of chlorine gas feeders as a means of*

- 28 (1) An owner shall ensure that a [recreational pool, semipublic pool, or] public *pool or spa* has a  
29 vacuum system for cleaning the pool or spa floor.

31 outlet pipes for vacuum purposes for *a* circulation [systems] *system* with four or fewer skimmers.

33 owner of a [recreational pool, semipublic pool, or] public *pool or spa* shall ensure that a vacuum  
34 system is provided that is separate from the skimmer or gutter system.

17 *patrons and operators of carbon dioxide levels at or exceeding 1000 ppm or an oxygen*  
18 *concentration at or below 19.5 percent.*

19 G. Ozone Systems. An owner of [a recreational pool, semipublic pool, or public spa] *an aquatic*  
20 *venue* shall ensure that:

21 (1) *Chemicals, solvents, or combustible materials, other than those required for the operation of*  
22 *the recirculation and ozone generating equipment, are not stored in a room where ozone is used;*

23 (2) *Rooms which are designed to include ozone equipment are equipped with an emergency*  
24 *ventilation system capable of six air changes per hour;*

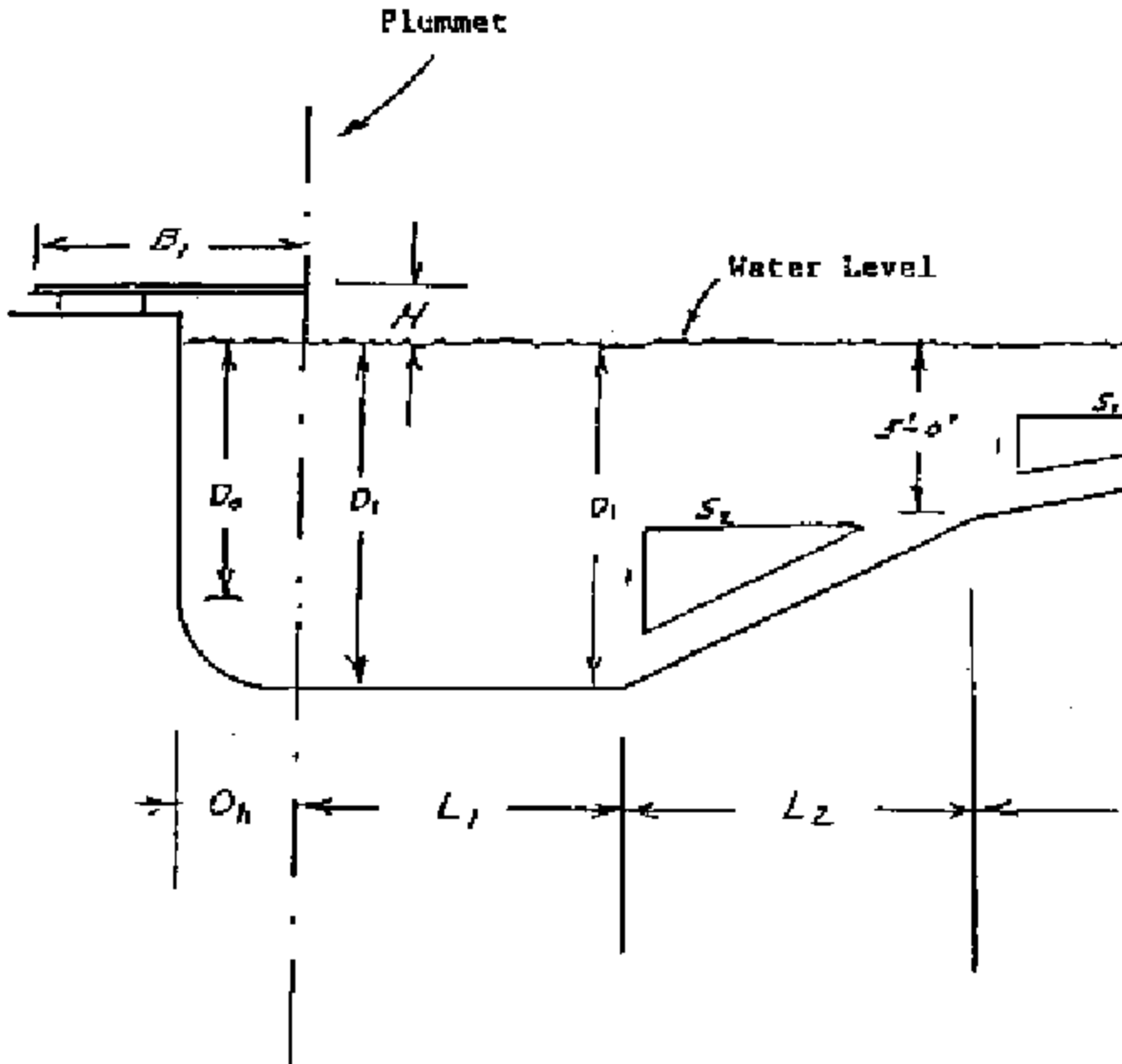

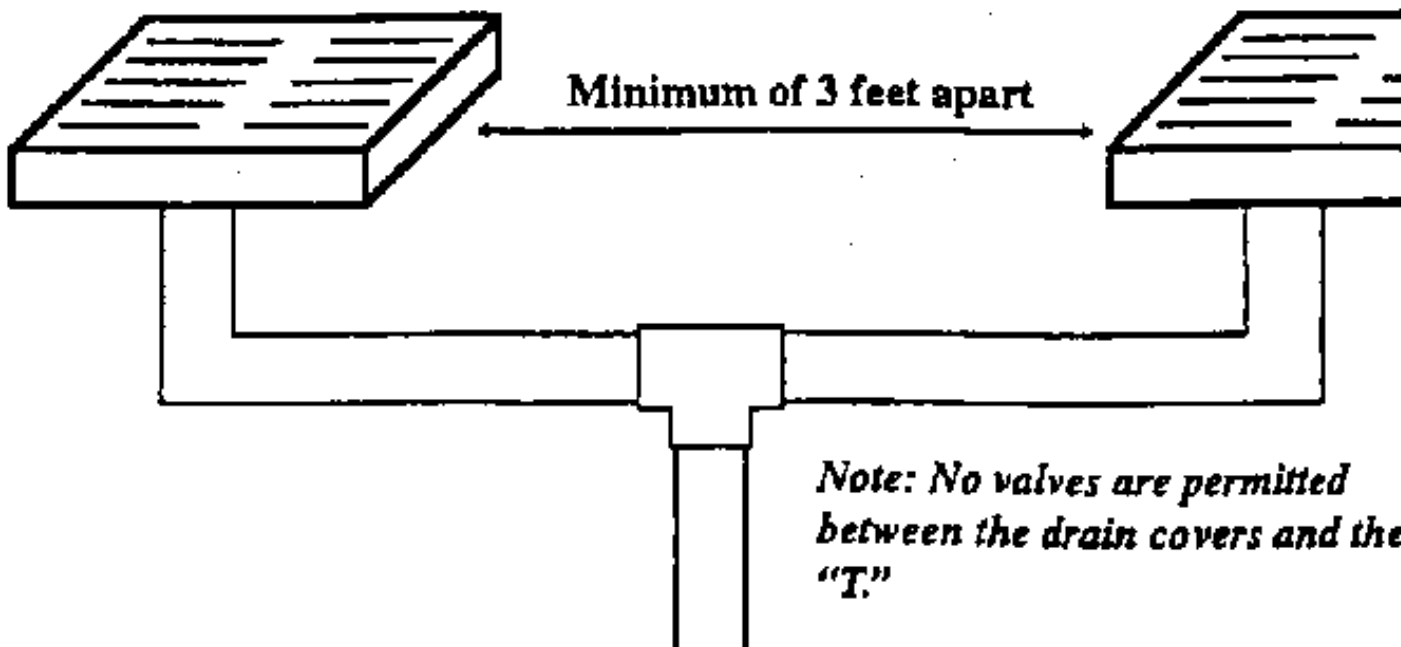

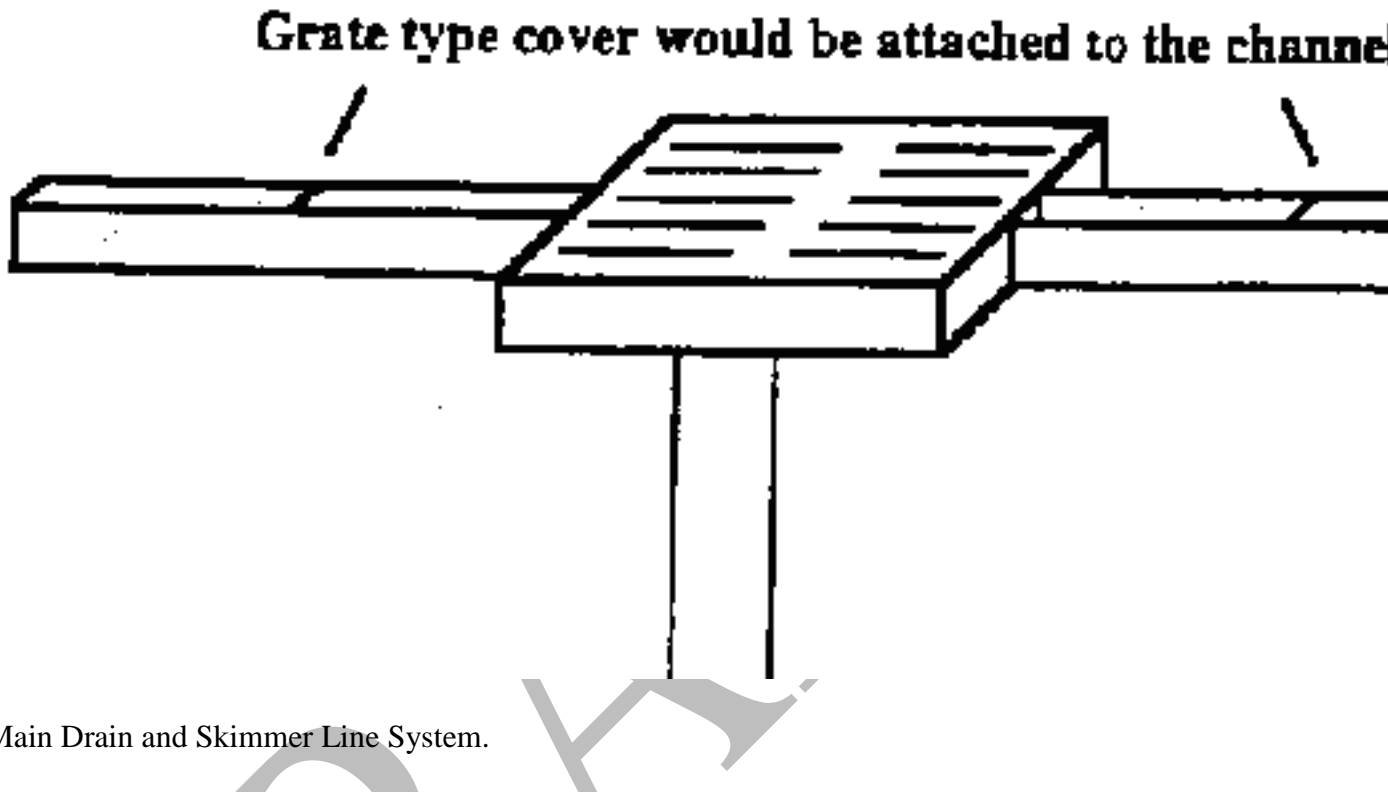
#### **A. Dual Drain System.**

1 **.53 Variances.**

2 A. An owner who has been granted a variance by the Secretary before February 10, 1997 may  
3 continue to operate under that variance.

4 B. An owner may request a variance from a requirement of this chapter by submitting a written  
5 application that:

6 (1) Contains specific details of the alternative procedure proposed by the owner;

7 (2) Specifies the applicable regulation to which the variance pertains;

8 (3) Explains the reason for the request;

9 (4) Provides the name and address of the owner;

10 (5) Provides the name and location of the facility; and

11 (6) Demonstrates that the alternative procedure proposed:

12 (a) Meets or produces the intended effect of the regulation for which the variance is requested[.];  
13 and

14 (b) Maintains the protection of the health and safety of the individuals using the facility at or  
15 above the level required by the regulation for which the variance is requested.

16 C. Upon consideration of an application for a variance, the Secretary may grant the request for a  
17 variance if the:

18 (1) Applicant has submitted an application in accordance with the provisions of §B of this  
19 regulation;

20 (2) Applicant has complied with all other applicable provisions of this chapter;

21 (3) Application is justified due to physical limitation of the existing layout of the facility; and

22 (4) Secretary determines that the alternative procedure proposed by the applicant:

1 (a) Meets or produces the intended effect of the regulation[.]; and

2 (b) Maintains the protection of the health and safety of the individuals using the facility at or  
3 above the level required by the regulation at issue.

4 D. The Secretary shall grant or deny an application for a variance in writing and shall mail the  
5 decision to the applicant within 60 *business* days of the date the application for a variance is  
6 received by the Department.

7 E. If the determination of the Secretary is to deny a variance request that has been made in  
8 compliance with the provisions of §B of this regulation, the applicant may file an appeal of the  
9 denial in accordance with State Government Article, Title 10, Subtitle 2, Annotated Code of  
10 Maryland, and shall contact the Secretary within 10 *calendar* days of receipt of the denial to  
11 preserve a right to a hearing.

12 F. A local health department that issues or denies a variance under the authority of the Secretary  
13 shall mail a copy of the variance application and response to the Department within 60 *business*  
14 days of the date the application for a variance is received by the local health department.

### 15 **.54 Compliance Schedules.**

16 A. The owner of [a public pool or, spa] *an aquatic venue* that has a structure, equipment, or  
17 appurtenance that is not in compliance with this chapter as determined by the Secretary may  
18 submit to the Secretary for approval a compliance schedule for meeting the requirements of this  
19 chapter.

20 B. The request from an owner for approval of a compliance schedule shall include:

21 (1) The reason that the [noncompliance] *noncompliant* item cannot be immediately corrected;

22 (2) The plan for correction of the [noncompliance] *noncompliant* item; and

23 (3) The time schedule for the correction of the [noncompliance] *noncompliant* item.

24 C. The Secretary may approve the compliance schedule if the:

- 1 (1) Owner has submitted a written request for approval of a compliance schedule in accordance  
2 with §B of this regulation;
- 3 (2) Time schedule for the correction of the [noncompliance] *noncompliant* item is accepted by  
4 the Secretary; and
- 5 (3) Operation of [the pool or, spa] *an aquatic venue* during the time allowed to bring the [pool or,  
6 spa]*aquatic venue* into compliance does not adversely affect the health and safety of the public.
- 7 D. The Secretary may not approve a compliance schedule for a newly constructed [pool or, spa]  
8 *aquatic venue* that has not received construction approval under Regulation .08 of this chapter.
- 9 E. The Secretary shall issue an operating permit or shall refrain from suspending an operating  
10 permit to an owner if:
- 11 (1) A compliance schedule has been approved by the Secretary for the correction of a  
12 [noncompliance] *noncompliant* item;
- 13 (2) The owner is following the approved compliance schedule; and
- 14 (3) [The pool or, spa] *An aquatic venue* is otherwise in compliance with this chapter.
- 15 *F. A local health department that issues or denies a compliance schedule under the authority of*  
16 *the Secretary shall mail a copy of the compliance schedule application and response to the*  
17 *Department within 60 business days of the date the application for a compliance schedule is*  
18 *received by the local health department.*

21 *(1) Tests all metal and electrical equipment connected with the aquatic venue;*

1 (3) *Submits the bonding certification affidavit to the Department prior to the previous bonding*  
2 *certification affidavit expiring.*
