CHW Specialty Certification - Chronic Disease Management: Diabetes

Goals: Expert stakeholder meetings to consider the minimum hours required to obtain a specialty certification. May require potential amendments to COMAR.

Plan:

- 1. Conduct a literature review
- 2. Develop application and evaluation materials for the stakeholder group
- 3. Hold 3 meeting (2 hours each)
- 4. Collect and analyze feedback/recommendations
- 5. Send recommendations to other MDH/experts for feedback
- 6. Use recommendations and feedback to draft potential amendments to COMAR
- 7. Present feedback to CHW Advisory Committee
- 8. Complete process for adoption of the regulations

Comments:

- May training programs applying for accreditation add on a specialty and offer all at once?
- Might supervised practicum requirement be through an employer?
- Might renewal requirements count toward both general and specialty renewal?
- 80 practicum hours may be high.
- Consistency across specialty certification requirements would assist with ease of implementation and management.
