CHW Certification Update



Certification Application – Deadline Suspension

Related to COVID-19

- Sec. Neall suspended the March deadline for CHWs to submit applications for certification based on experience until 30 days after the state of emergency has been terminated
- 500 CHWs certified as of the original deadline of March 31
- The deadline suspension has allowed an additional 177 CHWs to be certified to date!

CHW Certificate Renewal Application

- The CHW Certificate Renewal Application is open on Maryland OneStop
- CHWs are encouraged to begin their application once they are certified
- Applications are submitted 30 days prior to the certificate expiration date



CHW Certificate Renewal Application - webinars

- Six CHW Certificate Renewal Application webinars offered between October 21 and November 14
- 193 individuals registered

 - The Maryland OneStop CHW Certificate Renewal application
 - Process for documenting 20 hours of professional development activities

CHW Certification Training Program Accreditation Application

Accreditation Application Due Dates

- December 31, 2020
 - Training programs who trained individuals from Oct. 1, 2018 Dec. 31, 2020 requesting retroactive accreditation to October 1, 2018
- No deadline for:
 - Programs not requesting retroactive accreditation
 - New programs



CHW Certification Training Program Practicum – Recommended Accommodation



CHW Certification Training Program Accreditation - Practicum accommodation CHW Certification Training Program Practicum -Recommended Accommodation - Background

- A CHW certification training program shall verify successful completion of an additional supervised 40-hour practicum by a student. (<u>COMAR 10.68.02.03.A(2)</u>)
- 2. As a result of COVID-19:
 - There have been changes in the education, training, and employment venues
 - There is a concern that some CHW students may have difficulty finding a Practicum, but given how valuable CHWs are in addressing the COVID-19 pandemic, they may be able to find employment as a CHW



CHW Certification Training Program - Accommodation

 The Advisory Committee met on September 24 and October 9 to consider an accommodation to the Practicum component of accredited CHW certification training programs during the COVID-19 state of emergency

• If approved by the Department, accredited CHW training programs will be able to accept CHW employment in place of the 40-hour supervised Practicum if certain conditions are met





Health General § 13-3705(a)(1)(iii)

An apprenticeship program registered with the Department of Labor, Licensing, and Regulation may be accredited by the Department as a certified community health worker training program.

Health General § 13-3705(a)(2)

The Department, working in collaboration with the Advisory Committee, shall adopt regulations establishing a procedure for accrediting community health worker training programs.



Request: Three to five members of the Advisory Committee to participate in a workgroup

Goals:

- Consider the accreditation of apprenticeship programs registered with the Department of Labor
- Proposed amendments to the regulations

Time commitment:

• Three meetings between November 2020 – January 30, 2021



Meeting #1: Discuss the accreditation process for apprenticeship programs

Meeting #2: Proposals for regulation language

Meeting #3: Finalize draft language to be presented at the Feb. 16 Advisory Committee meeting
