Webinar: Housing Instability of Older Adult Renters and Homeowners

Maryland Philanthropy NETWORK Advancing Impact

Friday, October 8

The MPN's Baltimore Seniors and Housing Collaborative in partnership with the Community Development Network of Maryland and the Maryland Consumer Rights Coalition are holding a webinar on housing security for seniors.

The webinar will provide information on how to collaborate and support a coordinated, equity-focused response to housing insecurity for seniors. There would be a panel of experts who will present research on reverse mortgage patterns among senior homeowners in Baltimore City, research on the lack of sufficient affordable housing available to a growing share of senior renters, and plans for the launch of a federal stimulus aid to prevent mortgage foreclosure in Baltimore City and the state of Maryland.

The expert panel to lead these discussions include:

Ira Goldstein, PhD, President of Policy Solutions at Reinvestment Fund will present on reverse mortgage activity in Baltimore City for the past decade.

Jun Zhu, PhD, Associate Professor of Indiana University-Bloomington-Kelley School of Business and Non-Resident Fellow at Urban Institute will discuss findings on demographic shifts challenging communities to plan for a growing number of low-income senior households seeking rental housing.

Claudia Randall Wilson, Executive Director of Community Development Network MD will provide an overview of Maryland's mortgage foreclosure prevention stimulus funding allocations.

The Maryland Higher Education Commission (MHEC) has opened the 2021-2022 Tuition Reduction for Non-Resident Nursing Students application to non-Maryland residents. All applications and required documents can be submitted to the Office of Student Financial Assistance on a rolling basis.

To apply, applicants will need to create or log into their existing Maryland College Aid Processing System (MDCAPS) using the link here. Once logged into the MDCAPS account, applicants can submit their applications and view any additional required documents using the "Apply" link.
