GENERAL RULES FOR PERMITTED "OPEN BURNING"

1. A permit must be secured for each burning operation where conditions cannot be met for allowed open burning.
2. A hazardous condition, air pollution or nuisance may not be created and all reasonable means must be employed to minimize smoke.
3. Materials which produce dense smoke such as tires and roofing materials will not be burned.
4. The material to be burned shall have originated on the premises on which it is to be burned.
5. Fire Control Laws or regulations of other Governmental agencies will not be violated.

I agree to comply with the "Regulations Governing the control of Air Pollution in the State of Maryland" Area VI, COMAR 26.11.07 and the general conditions stated above. I will comply with all local, County and State Laws and Regulations while doing this burning. Also, I will notify the QUEEN ANNE'S COUNTY EMERGENCY SERVICES, 410-758-4510, before burning.
